Message from the Chairman

' t always gives me great satisfaction to introduce the annual report of the Ananta Centre. Each issue strengthens my belief that constructive change is possible, one important conversation at a time. Change is the consequence of action.

As the world grapples with climate change, economic disparities, social injustice, and geopolitical tensions, it is becoming increasingly important to have institutions like the Ananta Centre that work to inspire exemplary action through leadership and dialogue.

Public policy is an important area of work for the Centre. It holds public sessions and roundtables to help different groups exchange ideas and perspectives. The discussions this year focused on issues that are becoming increasingly critical for India's development: energy and fuels, technology and R&D, and crypto digitization. International conversations were crucial as well. Experts from 20 different countries convened for the Digital Roundtables on China's Foreign Policy Towards Asia to share perspectives on China's engagement with the key regions in its neighbourhood. The Centre also convened a roundtable on the India-UAE Partnership to deliberate on the opportunities available to both countries in the wake of CEPA. Signing the agreement has unlocked a hundred billion dollars in bilateral trade: both countries need to create conditions under which economic, technological, and regional cooperation can move forward.

The Ananta Centre held the Trilateral Commission Plenary meeting in New Delhi this year. This was the first plenary meeting held in India and commemorated the 50th anniversary of the Commission. The plenary covered a wide range of key topics, including India's politics, economy, and society; the war in Ukraine; geopolitics in the Indo-Pacific; the global food crisis; supply chains; and whether social media enhances or undermines democracy.

This annual report highlights the Centre's work but, more importantly, underscores the power of collective action in addressing the most pressing challenges of our time. I would like to extend my heartfelt gratitude to each of you who have placed your trust in Ananta and its mission. Your generosity and support are what propel us forward. Let us continue to work towards a more just, peace-

Tribute to Shinzo Abe: His legacy and the future of Indo-Pacific

22 JULY 2022 / The tragic assassination of the former Japanese PM Shinzo Abe not only shocked the world, it prompted a reflection on how many geopolitical alignments changed because Prime Minister Abe imagined a different global system. Certainly, India lost a friend. From the first strategic partnership with Prime Minister Manmohan Singh in 2006 to the 'special partnership' between Prime Minister Narendra Modi, Abe-san straddled India's political divides



with ease. We at Ananta Centre too have lost a friend. Over the past 15 years, our Japan portfolio has grown enormously - from strategic dialogues to MPs exchanges and the India-Japan Forum, Ananta has worked hard to establish deep bonds with our partners in Japan. Abe-san was a staunch supporter of our work, and was always available for our delegations whenever they visited Japan, making time to meet them, quiz them on the outcome of the dialogues, offer suggestions and ideas.

On July 22, Ananta Centre put together a tribute to Shinzo Abe by a high level panel from all the Quad countries - Abe-san is generally regarded as the father of the Quad. Foreign minister S. Jaishankar and Ananta's founder trustee Tarun Das joined from India, Kurt Campbell, Indo-Pacific Coordinator at the White House and John Hamre. President and CEO, CSIS; Tony Abbott, former PM of Australia and Tomohiko Taniguchi and Eichi Hasegawa, Abe-san's closest advisers joined in from different corners of the world.

India-UAE Partnership: Unfolding **Opportunities**

11 MAY 2022 / The Ananta Centre and the Embassy of the United Arab Emirates in New Delhi convened a roundtable titled 'India-UAE Partnership: Unfolding opportunities' on 11th May 2022.

The interaction on emerging avenues of cooperation and opportunities between India and UAE was held with Abdulla Bin Toug Al Marri, UAE Minister of Economy; Ahmad Belhoul Al Falasi, UAE Minister of State for Entrepreneurship & SMEs; Ahmed Albanna, UAE Ambassador to India. Anuj Poddar, Executive Director, Bajaj Electricals Limited & Trustee, Ananta Centre chaired the roundtable.

The roundtable recognized that the signing of the UAE-India CEPA unlocked a hundred billion dollars of bilateral trade over the next five years between the two nations. The participants acknowledged an opportunity for both the countries to work towards regional security, to create



a larger condition under which the economic cooperation, technological cooperation, and regional civilization can move forward. The deliberations was closed-door and held under Chatham House rules.

During the three days of meetings, participants heard from S. Jaishankar, India's Minister for External Affairs; Gan Kim Yong, Singapore's Minister for Trade and Industry; and Taro Kono, Japan's Minister for Digital Transformation, among others.

Indicating India's growing importance on the global stage, the plenary covered a wide range of key topics such as Indian politics, economy, and society, alongside the war in Ukraine, geopolitics in Indo-Pacific, the global food crisis, supply chains, and whether social media enhances or undermines democracy.







The Trilateral Commission Asia Pacific Group

Regional Meeting

19–20 NOVEMBER 2022, TOKYO, JAPAN

The Trilateral Commission Asia Pacific Group Regional Meeting was held to promote dialogue on key issues facing the international community. Minister for Foreign Affairs of Japan Yoshimasa Hayashi also gave a speech and held discussions with the participants from Asia Pacific Group.

The discussions focused on the current political, security, economic, and social situations of countries in Asia Pacific; the normalization of fiscal and monetary policies in the post-COVID era and its impact on emerging economies;





new geo-economic conditions and supply chains; emerging regional frameworks; and the impact of new technologies on people's lives and on policy. The meeting recognised the need to engage China in the Asia-Pacific as the region's largest economy. The discussion further expanded into current geopolitical events and India's engagement with regional geopolitical realities.



Chandrasekaran, Chairperson, Tata Sons The first in-person edition of the Forum since the pandemic was bigger and better than ever before. Held in January, 2023 it brought together 200 eminent representatives from across stakeholder groups under one roof including three Indian Cabinet ministers and three US Cabinet Secretaries.

A closed-door engagement held under the Chatham House Rules, the Forum reaffirmed the depth of the bilateral relationship and explored new avenues of collaboration in the Indo-Pacific, defence production, emerging tech, data governance, energy, supply chains, climate change, G20, trade, and economic engagement while assessing the evolution of the great power dynamics in the aftermath of the pandemic, the Russia-Ukraine war and other geopolitical shifts.

High level engagements and bilateral summits have intensified and indicate a growing commitment by the leadership on both sides. Looking ahead, New Delhi and Washington must continue to build on their strategic convergence and partner closely as India takes on the G-20 Presidency.

Salient points

- Friend-shoring should not become a euphemism for de-globalisation. A cautionary tale, given the preeminent position of the US and India's position in the G20 this year, there are two risks. First is the slowing growth and second is ill anticipation of financial accidents after decades of liquidity. This is where the US and the G20 need to come together.
- To become geopolitically strategic, India-US relations have to become more strategic in economics and technology. India has been proactive in taking this relationship forward, resulting in a growing confidence in each other. The continuing implications of the pandemic on the global economy, the fundamental questions it raised about supply chains and reliance of the global economy on a single country are still in play.
- The sign of a mature relationship is having multiple lines of efforts, whether it is political investment or strategic imperatives. If too much burden falls on "the next big thing" and it does not actualise then the relationship is considered to have failed in some ways. Strategic convergence in the Indo-Pacific can be considered "the next big thing".
- Two new domains have emerged—technology and the

need to diversify supply chains out of China into geographies that can be trusted. This will entail a degree of home shoring and friend shoring. It does not mean there will be complete agreement and alignment.

- Neither the US nor India control the means of production over technology. A lot of the technology used around the world is produced by China. Both governments are pushing forward on various actions to be taken against China on technology. There will be a lot of US companies that would want to move out of the Chinese markets into markets around the region. Companies will have to be incentivised to move to India and South East Asia, places with like-minded values.
- The issues of data governance and data trade should be recognised as central to US-India shared interests and shared security concerns.
- India and the US are extremely aligned right now, their shared vision for the Indo-Pacific is driven by a lot of convergence. Without a strong US-India defence partnership, a militarily capable US and a militarily capable India, there is no scope for maintaining a stable balance of power in the region. Increasingly, those capabilities have to be interoperable so they can respond to crises together.
- The US-India Initiative on Critical and Emerging Tech-





nologies (iCET) and other initiatives in the US Department of Justice (DoD) are a big focus of their bilateral conversations.

- The ecosystem of challenges experienced by India and the US across the maritime stretch of the Indo-Pacific makes the Indian Ocean an opportune area of discovering and shaping new partnerships. Conceptually, one of the challenges in the Indo-Pacific is maritime multicentricity — within which the Indian Ocean is a key central focus.
- In the next 30 years, India is going to face an energy

demand which is equal to the size of the European Union's current energy demand. India has to be able to use the fact that it is a major player in the energy segment going forward. The US will play a pivotal role not only in supporting India's rise as a global power but also in supporting India's rise as a global superpower for green energy. The bilateral SCEP gives a strong platform to focus on the shared decarbonisation challenge.

Critical minerals security requires resilience and foresight which the world has not yet shown. Forums like the Quad have to figure out how to get access to these raw materials.


There is a huge pipeline of Indian students into America and that is worth preserving. There are many issues around visas and immigration that the US needs to deal with domestically. It should be highlighted that this is a positive two-way exchange. There has been talk of a "million talent programmes". To bring in talent from around the world to work together in STEM, India is a key place. This two-way flow of talent should continue to build the ties between people in these fields.

Additionally, the Summit will address rising geopolitical tensions, food and energy security concerns, growing debt distress, and inflationary pressures.

LiFE: India's Mission for Green Transition

Several non-state actors are thriving in the political vacuum: the Islamic State Khorasan (IS-K) has carried out several offensive strikes, and directed assaults in Uzbekistan and Tajikistan, and al-Gaeda has been laying its bases under the radar.









Recep Tayyip Erdogan scrambled to save face as slow relief efforts and reports and videos on construction scams fuelled public outrage. With elections for the presidency and parliament just months away, the emergency powers invoked by Erdogan to deal with the aftermath of the catastrophe could curtail public opinion, gag the media, and even lead to the postponement of the elections.

The first earthquake, of 7.8 magnitude and lasting 75 seconds, struck at 4.17 am local time on 6 February, in the middle of a winter storm. 

In the report to the 20th National Congress of the Chinese Communist Party (CCP) in October 2022, CCP General Secretary Xi Jinping said, "China will continue to strive for peaceful reurification with the greatest sincerity and utmost effort, but we will never promise to renounce the use of force. We reserve the option of taking all measures necessary." This was not the first time that China has referred to the use of force in case of reunification with Taiwan. The People's Republic of China (PRC) has consistently refused to rule out the use of force if Taiwan takes overt actions toward independence and has built military capabilities to make this threat credible. Furthermore, the Chinese government, in its 2020 work report to the Chinese National Party Congress (NPC), had also dropped the word "peaceful" while referring to reunification with Taiwan, breaking with nearly three decades of precedent – also indicating the worsening of the cross-strait relations.
